What is a Congressional Record? A Congressional Record is documentation of activitiy (e.g., debates, legislative bills introduced, resolutions, etc.) carried out on the house floor by members of Congress. All documentation of these proceedings become permanent records of the United States Congress.

Legislative Updates

These updates are provided to keep you informed of legislative activities in Washington, DC.

- 1. Congressman Thompson cosponsored S. 1530, the Universal School Meals Program Act. This legislation would permanently provide free breakfast, lunch, dinner, and a snack to all school children regardless of income, and strengthen local economies by incentivizing local food procurement.
- 2. Congressman Thompson cosponsored H.R.2102, the End Polluter Welfare Act. This bill limits or eliminates certain fossil fuel oil and gas subsidies for oil companies.
- 3. Congressman Thompson signed onto a letter requesting a permanent Covid-19 Health Care Standard for Health Care Workers. This letter requests that Occupational Safety and Health Administration (OSHA) immediately issue a permanent health care standard to protect at-risk workers.
- 4. Congressman Thompson cosponsored H.R.5819, the Autonomy for Disabled Veterans Act. This bill amends title 38, United States Code, to increase the amount paid by the Secretary of Veterans Affairs.

SOCIAL SECURITY ADMINISTRATION

January 1 through March 31 2022, Medicare Advantage enrollees can switch from one Medicare Advantage plan to another at www.Medicare.gov. Clients can apply for Medicare online by meeting the requirements:

- Are three months away from age 65.
- Do not want to start receiving Social Security benefits at this time.
- Are not currently receiving Social Security retirement, disability, or benefits.

USDA EXPANDED CONSERVATION PROGRAM OPPURTUNITIES

The U.S. Department of Agriculture is announcing several new expanded oppurtunities for climate smart agriculture in 2022. Updates include nationwide avaliability of the Environmental Quality Incentives Program (EQIP) Conservation Incentive Contracts option, a new and streamlined EQIP Cover Crop Initiative, and added flexibilities for producers to easily re-enroll in Conversation Stewardship Program. Watch for Advance Child Tax Credit Letter

In December 2021, the IRS began sending letters and will continue through January 2022. The letter will include the total amount of advance Child Tax Credit payments each tax payer recieved in 2021. It will also include the number of qualifying children used to calculate the advance payments. People should keep this and any other IRS letters about advance Child Tax Credit payments with their tax records. Families who received advance payments will need to file a 2021 tax return and compare the advance Child Tax Credit payments recieved in 2021. People who received the advance CTC payments can also check the amount of their payments by using the CTC Update Portal available on www.IRS. gov. Eligible families who did not recieve any advance Child Tax Credit payments can claim the full amount of the Child Tax Credit on their 2021 federal tax return, filed in 2022.
